George Ambrose White was born on March 14th, 1877 at 23 Goswell Terrace, in Clerkenwell, London. His parents were Robert William White and Maria Ridley. He performed as a comedian using the stage name George Flexmore. He became a West End Representative of the Associated Press. He married Ellen Mary Anne Dunn on February 27th, 1899 in Bethnal Green Registry Office. Ellen, using the stage name Lily Flexmore, was an accomplished performer, singer and comedienne in her own right. They had a baby daughter together on July 28th, 1899, while in Birmingham, but the infant, having arrived prematurely, did not survive. George Ambrose White died suddenly on September 26th 1933 at the age of 56. A procession of 40 newspaper delivery vans followed the funeral cortege. His wife, Ellen, passed away some four months following his death. They are interred together in Islington Cemetery.

12. 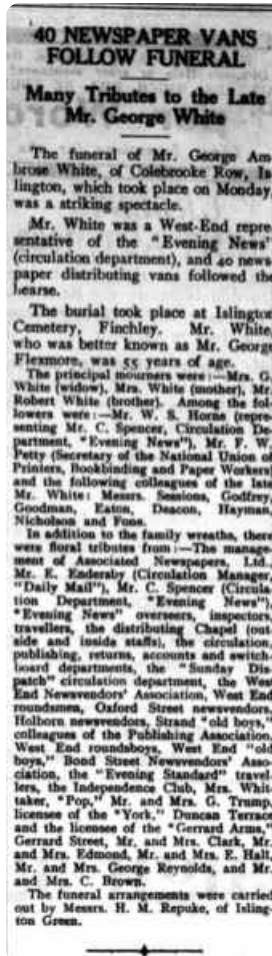
